SMEs Benefit from Supportive Business Environment

South Ribble Borough Council provides a supportive business environment for local businesses by offering links to support organisations and funding initiatives to help businesses develop.

Under a new policy small businesses and those in retail premises, such as shops and restaurants, will see a reduction in their business rates.

The reductions came into effect in April 2014. In an attempt to bring empty retail premises back into use, potential ratepayers will be offered a 50 per cent reduction if they take up a retail space which has been vacant for longer than a year.

City Deal to Generate Growth

A new City Deal has been agreed to accelerate local economic growth. Building on the success of the first wave of City Deals agreed last year, the Preston, South Ribble and Lancashire City Deal will drive forward local growth by encouraging areas to make the most of their economic assets.

Over a 10-year period, the deal is expected to generate more than 20,000 new private sector jobs, including 5,000 in the Lancashire Enterprise Zone and 17,420 new homes, whilst creating £1billion in economic growth.

The £434m scheme, led by South Ribble Borough Council, Preston City Council, Lancashire County Council and the Lancashire Enterprise Partnership, will make the area one of the most important economic centres outside of London and will act as a catalyst for growth - attracting an estimated £2.3bn of commercial investment.

This will open up new investment opportunities for businesses and provide new markets for goods and services.

Ron Augustyn, managing director of Leyland Trucks, said: "The focus on infrastructure means less congestion for employees. It will mean more houses and attract other businesses to invest here - hopefully more engineering companies to add to the skilled workforce, which will provide a larger talent pool for our recruitment efforts."

150th F-35 Aircraft Set Complete

BAE Systems has completed the manufacture of the 150th F-35 rear fuselage and tail set at its military aircraft factory in Samlesbury, Lancashire.

The set, known as AF070 is a Conventional Take Off and Landing (CTOL) variant destined for the US Air Force.

Jon Evans, head of production delivery, F-35 said: "We are now producing aircraft sets at a rate of one every five days thanks to the multi-million pound investment we made in the Samlesbury site, so we're well on the journey to being able to produce at a rate of one a day by 2018. With a potential requirement of 3,000+ aircraft, the scale of this programme is huge, and so is our commitment to deliver to it."

BAE Systems is responsible for the production of each and every rear fuselage and tail set. The company also plays a key role in vehicle and mission systems, life support systems and prognostics health management integration.

Leyland's Torotrak Completes £23m Takeover

Low carbon vehicle technology engineering company Torotrak has acquired Flybrid Automotive Ltd, technology leaders in flywheel-based hybrid systems for vehicles, in a deal worth up to £23m.

The company said the purchase of the remaining 80 per cent of Silverstone-based Flybrid provides a platform for the joint development and launch of Flybrid's Kinetic Energy Recovery System technology for various vehicle applications.

Torotrak, based on Aston Way, Leyland, believes the combination of the two businesses will allow for the development of low-cost, high-performance, hybrid systems for mass market adoption in both cars and commercial vehicles.

As part of the deal, Flybrid's managing director, Jon Hilton, will join the board of Torotrak, along with Doug Cross, Flybrid's technical director, joining the company as chief technology officer.

Jeremy Deering, chief executive of Torotrak, said: "This announcement marks a significant step in our strategy to capitalise on the substantial opportunities in global automotive markets in the next few years.

"The acquisition of Flybrid enables the group to commercialise an affordable hybrid system that the directors believe is capable of mass market adoption."

The firm develops Dual-Fuel™ technology which enables heavy duty diesel engines to run on natural gas. They saw a 25 per cent rise in turnover following interest in its products in Europe, reporting £9.9m for the year to 31 December 2013 - up £7.9m from the previous year.

Clean Air Power has simultaneously announced its entry into a funded concept development agreement with a global truck manufacturer to develop a dual fuel engine for the South East Asian market.

The company has also appointed a new chief financial officer, Neill Skinner, who

has previously worked in audit and lead advisory roles at global accountancy firms as well as holding positions in strategy and corporate development.

John Pettitt, chief executive, said: "Clean Air Power has delivered a strong performance, in line with market expectations, driven largely by the sales growth of our European products.

"We are very encouraged by the further opportunities generated by our Ricardo co-operation agreement. This will allow us to develop products quickly to address growing global demand that is evident from both manufacturers and operators."

Station On The Right Track

Leyland Railway Station is set for a major upgrade after £3.5m was made available for essential improvements.

Funding will enable the installation of a new footbridge and three lifts, providing access to all platforms for wheelchair users, people with prams and those with limited mobility.

The money has been made available as part of a £100m extension to the Government's Access for All programme, which aims to improve accessibility to the country's rail stations.

The announcement came just weeks after the completion of a new ticket office and other recent improvements at the station, such as new shelters and a CCTV system, carried out by South Ribble Borough Council, Lancashire County Council, Network Rail and Northern Rail.

Provision of lifts was the crucial improvement that South Ribble Borough Council had been lobbying for since 2008, after the authority garnered the support of local businesses and education establishments.

It comes as another huge and timely boost to the local economy, with work moving forward on the nearby Cuerden site at the end of the M65.

The exact schedule for the work has yet to be revealed, although it will be completed within the next phase of the Access For All programme.

The deal with Welsh Athletics sees Kukri as the team's official kit supplier until 2019. The kit will be worn by athletes competing for Wales, including school teams and those competing at this year's Commonwealth Games.

The sportswear firm will provide Warwickshire CCC's kit until the end of the 2016 season and is working on a unique design that will win the approval of players and fans alike.

Kukri will also provide Team Northern Ireland with bespoke off-field, leisure and travel kits for the Commonwealth Games. The firm had already brokered an agreement to kit out the England team and is hoping the games in Glasgow this year will boost the brand's profile and recognition.

Phil Morris, managing director, said: "We've seen an awful lot of growth. Our market share in the UK is about three per cent and we're the market leader, so there is huge potential in the bespoke area. In five years we'd like to think we'll be four or five times as big as we are now."
